Budget Forecast



FY17 Funding Landscape

• Funded under current continuing resolution until April 28 at the fiscal 2017 cap of \$1.07 trillion

Omnibus or second CR to complete FY funding

First budget resolution (reconciliation) to be debated in both chambers



FY18 Funding Landscape

- •President-elect Trump plans to submit a FY18 budget request to Congress, which could come in late Feb. or not until later in the spring
- •Budget proposal timeline February (topline) and May (detailed)
- •FY18 congressional appropriations process and schedule
- Expiration of Budget Control Act (BCA)
- Lifting of debt ceiling
- •New big spending on infrastructure, tax reform, defense
- No commitment on mandatory spending reform/cuts
- Spending pressure on non-defense discretionary






U.S. Global Health Funding as a Share of the Federal Budget, FY 2016 Request



Global Health USG Funding: Perception vs. Reality


Public Overestimates Share Of Budget Going To Foreign Aid

Just your best guess, what percentage of the federal budget is spent on foreign aid?







U.S. Global Health Funding, FY 2006-FY 2016 Request



U.S. Global Health Funding, Distribution by Agency, FY 2006-FY 2016 Request




U.S. Global Health Funding, Distribution by Sector, FY 2006-FY 2016 Request




Top 10 Donors for Global Health ODA, 2002 & 2012




